Evasion in France.

Lt. Compton:-

we had lost our ball turret before leaving England. Over
FLAK AND FIGHTERS the target ~~for~~ our #4 engine was hit by flak, and
as we straggled behind the formation fighters attacked
us, knocking out our oxygen and intercom systems
and then shooting off the tail of the ship. Lt. McCheaney
and I decided to leave the ship. ~~2000~~

I delayed my jump to a height of 2000 or 1500 feet. When
my chute opened I saw our plane breaking up and
a chute burning in the air 2000 feet above me. I
landed in a clearing, buried my chute and ran west,
and ran into a wood where I hid until 1700

hours. I saw some people while I was hiding,
but I did not disclose myself to them. At 1200 hours
I walked S along a small road through the wood
until after having gone several miles I came upon
two men and a boy on bicycles. I declared myself

I delayed my jump for two or three thousand feet, and as I fell I saw pieces of our plane falling all around me. I landed in a tree; and, since I couldn't get my chute down, I left my nose west under it and ran ^{southwards} through the wood in which I had landed. Thinking that I heard dogs and ~~perhaps~~ human voices I hid on the edge of the wood till dark and then proceeded ~~some~~ southwards once more. Presently ~~seeing~~ ^{seeing} a light in a farmhouse several kilometers away ~~and~~ I crossed fields and waded streams until I reached the house. A girl answered my knocking at the door, and the family within immediately welcomed me, ~~gave~~ set food before me, and dried my clothes at the fire. The father of the family went out and brought in another man who told me that one of my comrades was in the vicinity and a few hours later I was taken to the house where Lt. Compton was sleeping and from where our journey was arranged.

- a) At the German flying-school just S of TARBES ~~there~~ all grades of training ships from primary to advanced are in use. (Observation and Hearsay, February 1944)
- b) The arsenal in TARBES is manufacturing munitions for the Germans (Observation and Hearsay, February 1944)
- c) In SEMEAC (just E of TARBES) there is on the E side of Highway 117 which passes through the village an airplane-engine factory. (Observation, February 1944)
- d) At MINAUCOURT (16 kms N.W. of STE. MENEHOULD) and at POSSESSE (28 kms S. of STE. MENEHOULD on R.N. 382) there are important radar installations. The one at POSSESSE has as personnel 120 Blitzmädel and eight officers. (Hearsay January 1944)
- e) At Soissons and at Rheims the Germans are constructing fortifications and ~~are~~ along the Aisne are ^{preparing} ~~constructing~~ (over)

Appendix D.

1. ^{Aids box} From my aids box I used the ~~box~~ matches, chewing gum, compass, and sewing kit. Aid received on the evening of the day when I landed made further use unnecessary. ~~I burned the box.~~
2. Purse I had a red purse, and of its contents I used the map of northern France, the compass, and the 2000 French francs, all of which I gave to my keepers except for a small amount used to buy cigarettes. The maps, compass, and file I lost in the mountains.
3. Photographs I carried six photographs which were used for my papers.
4. Lectures I was lectured on evasion and escape at Kearney, Nebraska in September, 1943 and found the lectures valuable. I would advise readers to keep in the best possible physical condition while they are waiting to cross the mountains.

1. Aids Box I used the benzadrine tablets while crossing the mountains, ~~and~~ The adhesive tape and sewing kit I used at various times. Almost immediate aid made use of the other articles unnecessary.
2. Purse. I had a red purse from which I used the maps. The money I gave to my helpers; the maps, compass, and file I gave to the Frenchmen as souvenirs.
3. Photographs I carried six photographs which were used for my papers.
4. Lectures I was lectured on evasion and escape by an evader at Kearney, Nebraska, and found the lectures of great value.
